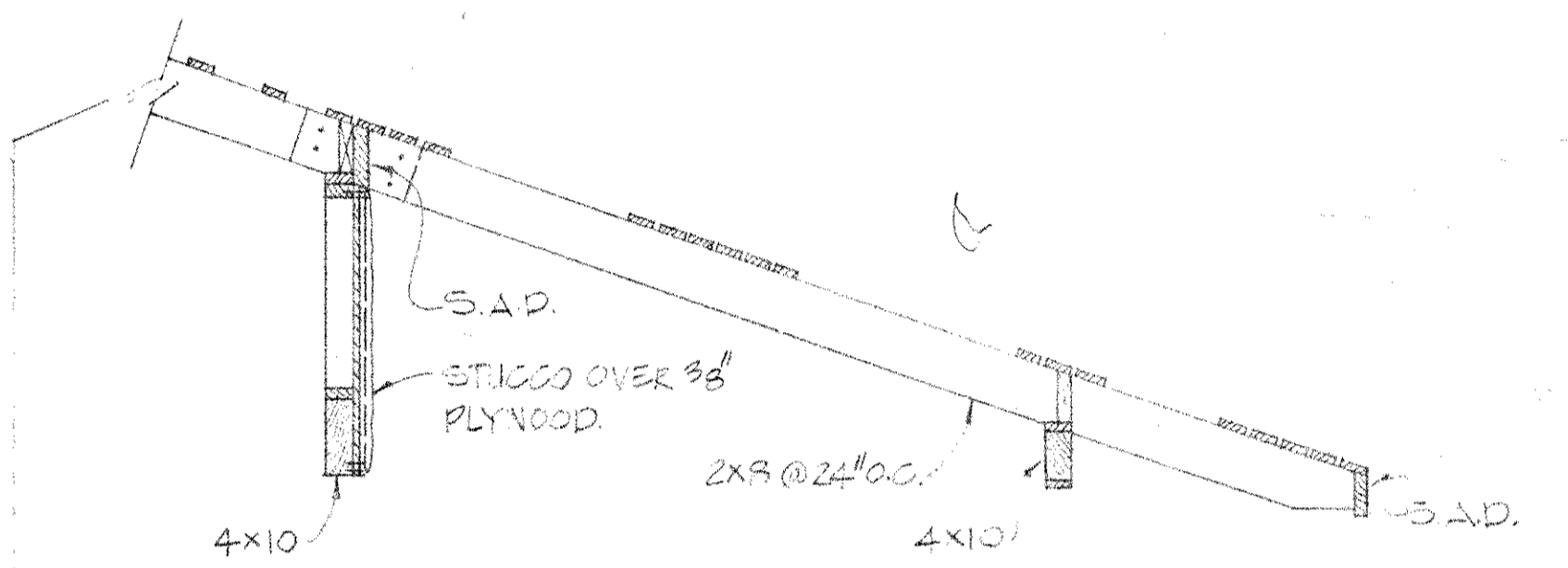

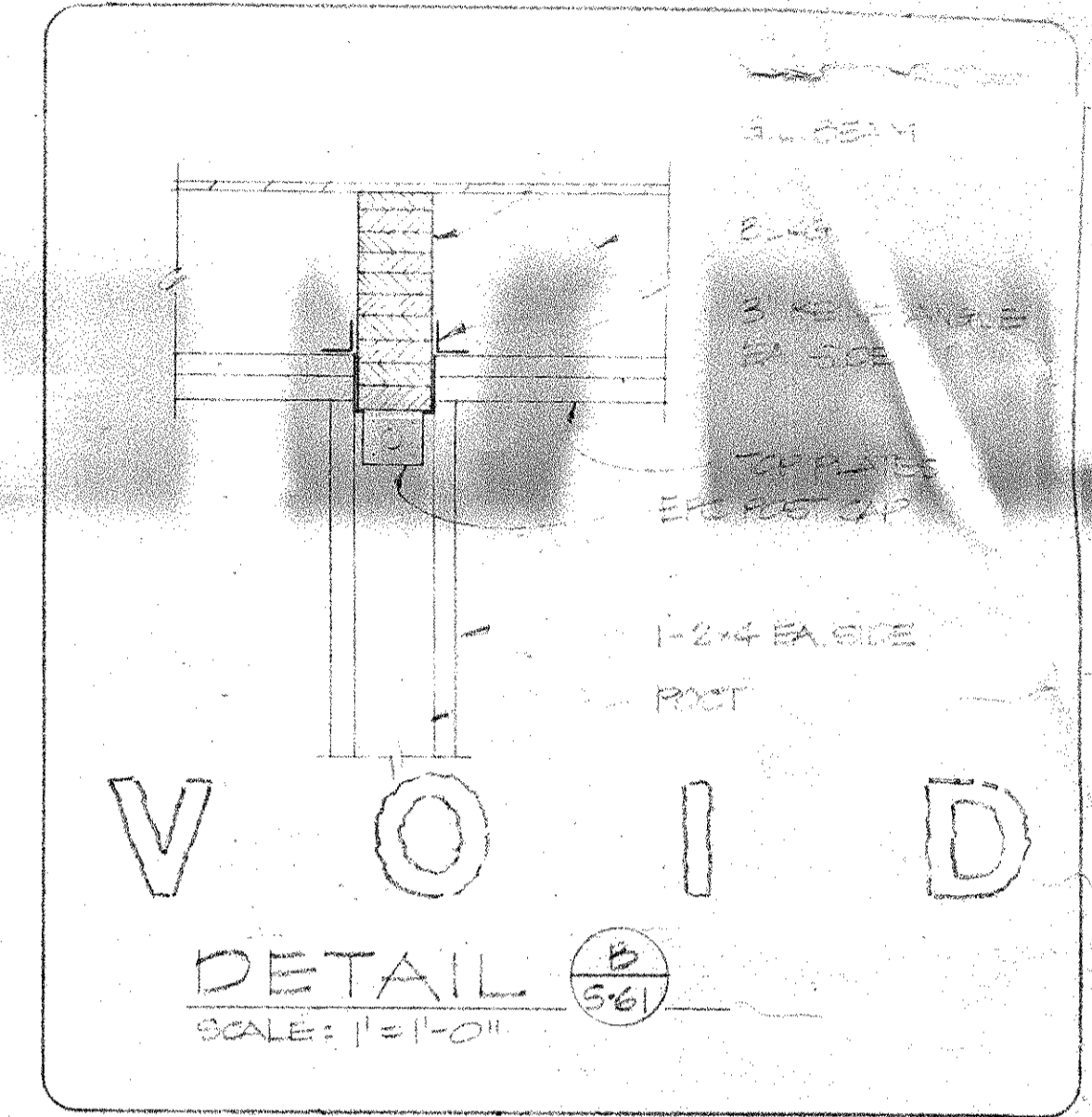


ROOF FRAMING PLAN

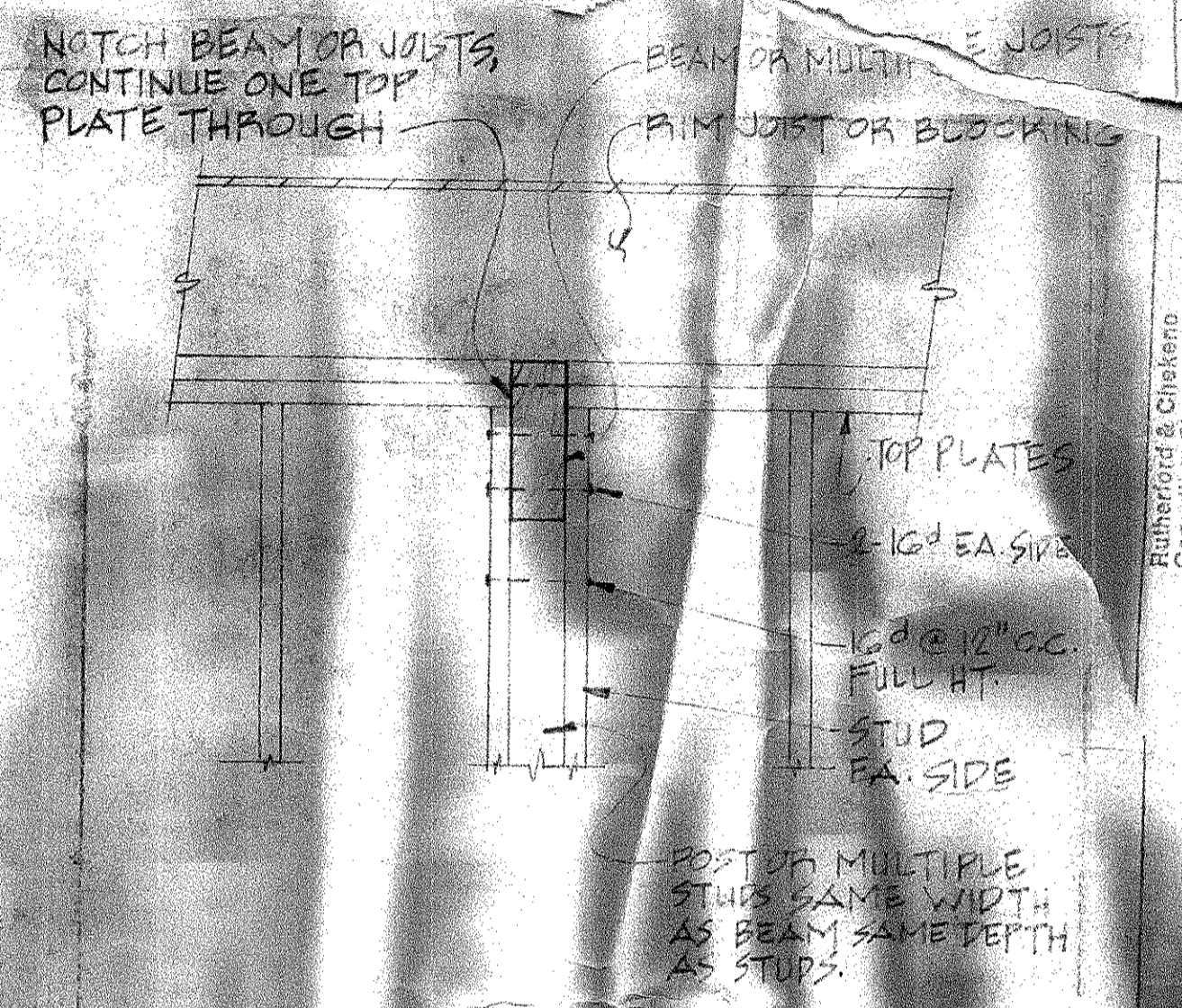
ROOF FRAMING PLAN

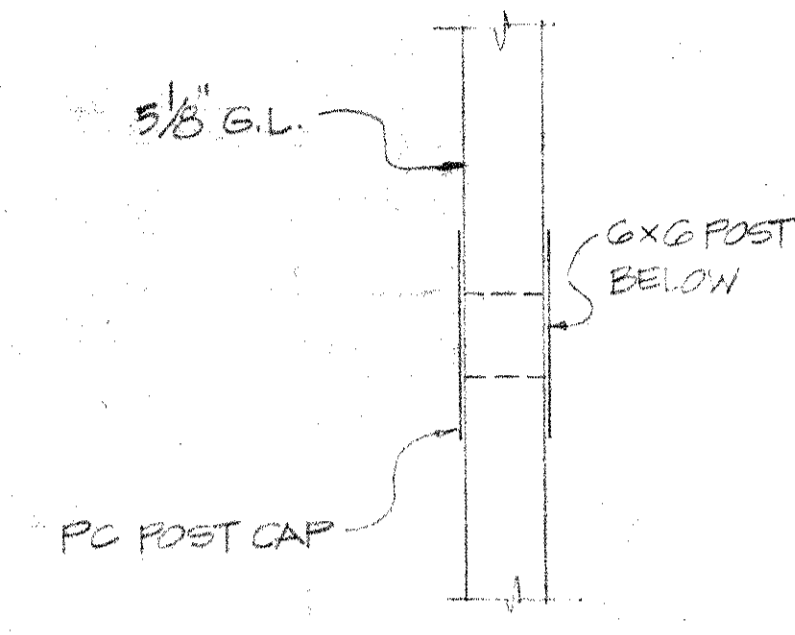


ELECTRICAL SITE

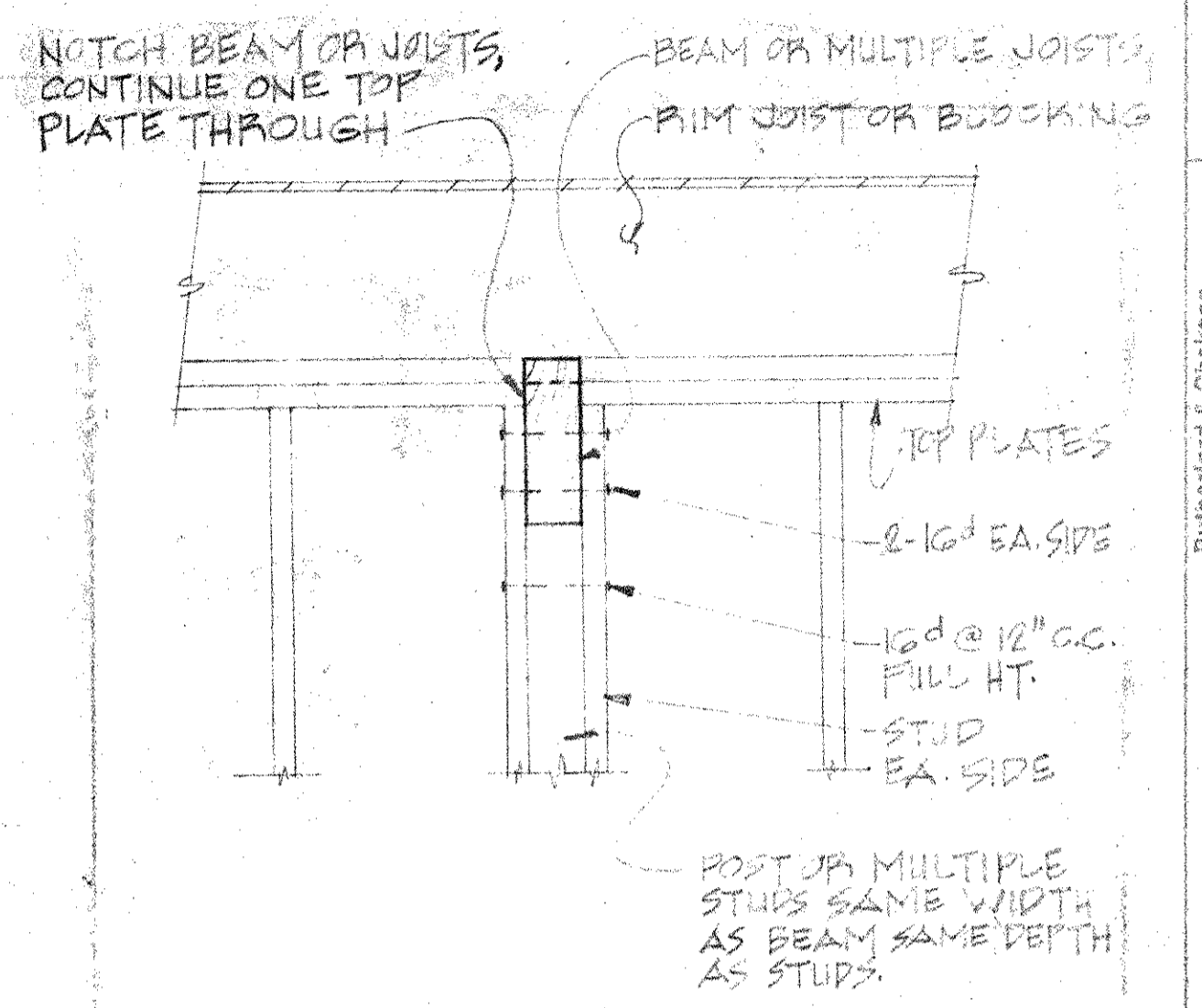
ROOF FRAMING PLAN

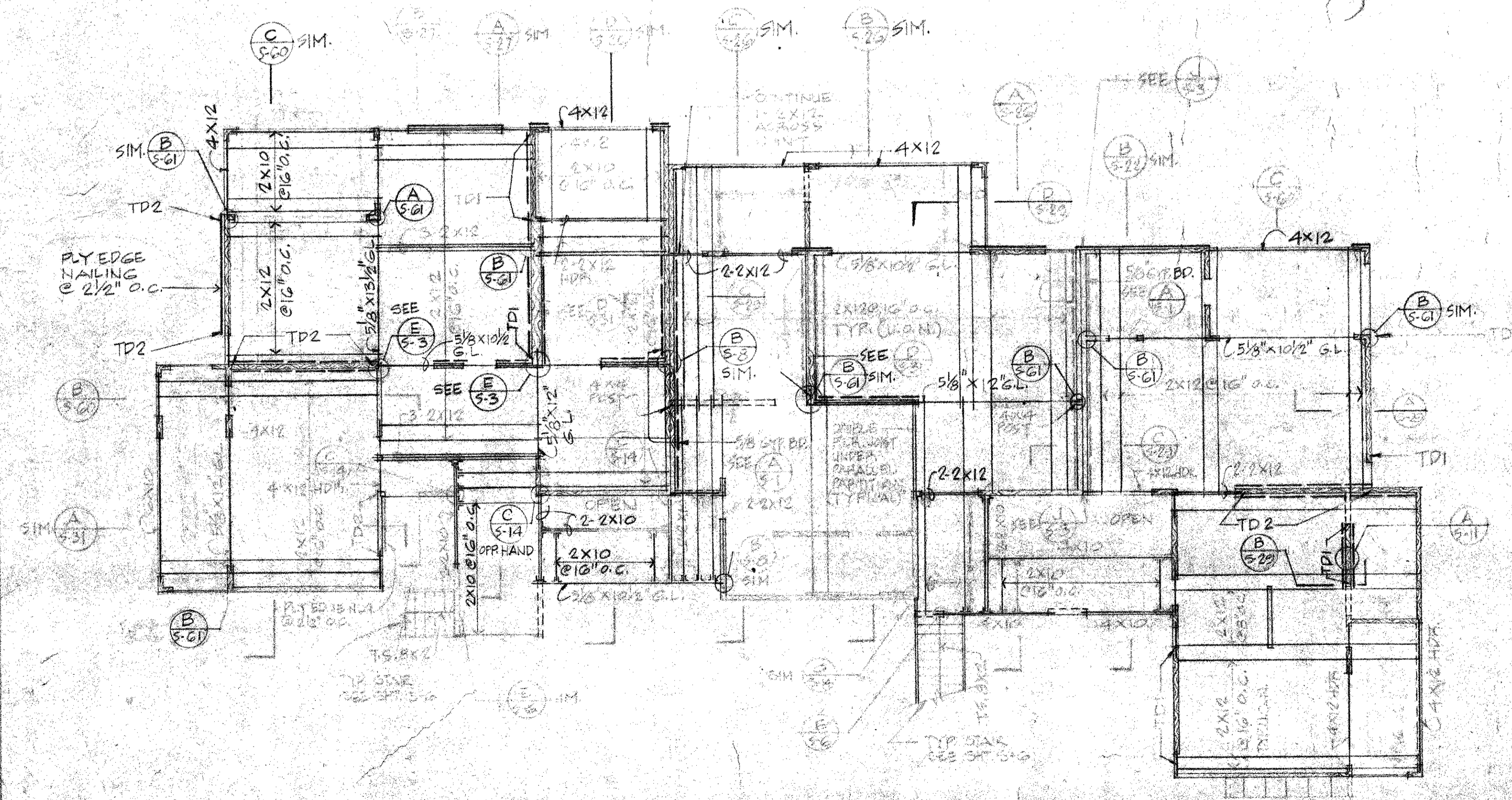

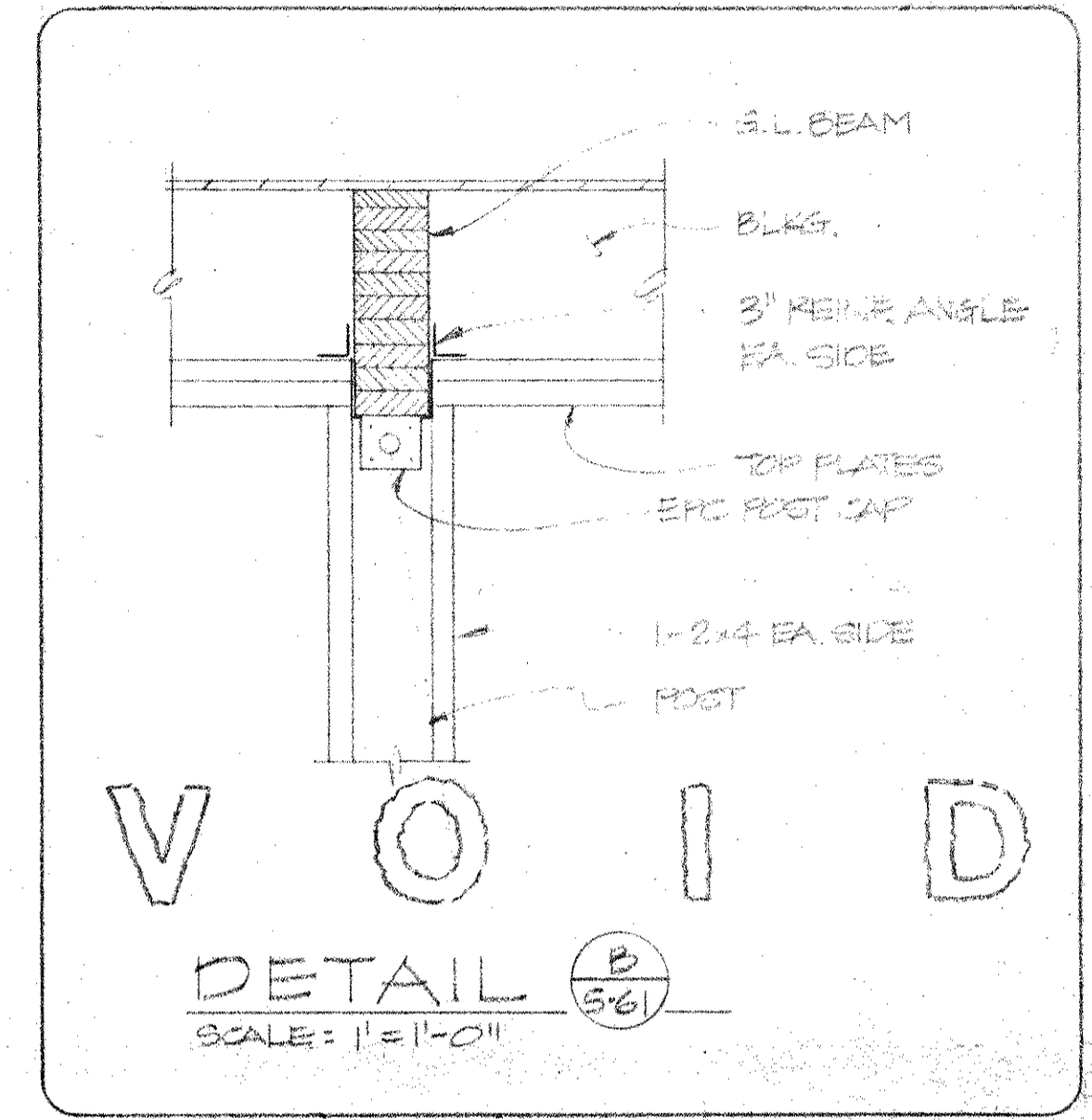


ROOF FRAMING PLAN

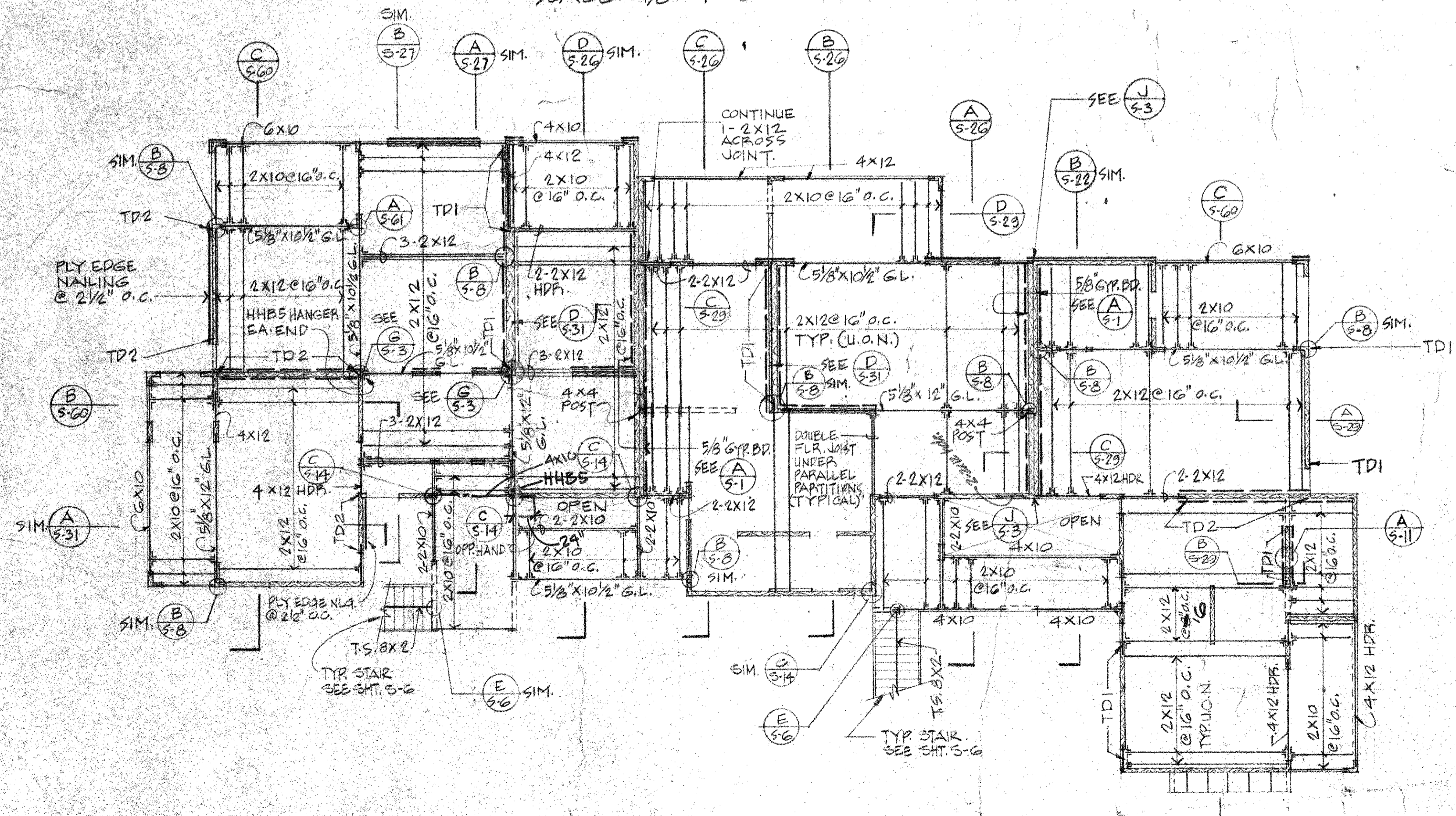
